### INFORMATION AND APPLICATION INSTRUCTIONS

As a service to the legal profession, ALI CLE makes a limited number of full and partial scholarships available for ALI CLE's live courses, webcasts, and online CLE (on-demand web courses).

#### Who should apply?

Judges; judicial law clerks; law professors; law students; retired attorneys 65 or older; law librarians; attorneys licensed fewer than five years; attorneys who work for nonprofit organizations, legal services organizations, or government agencies; and unemployed attorneys all are encouraged to apply. Attorneys in private practice who are in need and who seek to learn skills that will assist them in *pro bono* activities also are encouraged to apply.

#### How do I apply?

Please fill out the attached application form and return it with a sheet of your letterhead (if employed) or with a copy of your student ID. Applications for live courses on-site should be submitted at least four weeks before the start date. Applications for live webcasts and telephone seminars should be submitted at least two weeks before the scheduled date. Full scholarships can not be granted more than once in a 3 year period.
